

Health Requirements

- 1.) Negative Tuberculosis test (caudal fold) – All animals. Test performed within 60 days prior to sale date.
- 2.) Negative Anaplasmosis, Blue tongue tests. (Optional)
- 3.) Negative Brucellosis test – All Males. All Females that are not OCV'd and OCV'd females over 15 months of age. Test performed within 30 days prior to sale date.
- 4.) Bulls under 24 months of age must have signed statement from veterinarian on health chart certifying that they have not been exposed to breeding females. Non-virgin bulls under 24 months of age and all bulls over 24 months of age must have a negative PCR trichomoniasis test 30 days prior to sale date.
- 5.) Female Official Calfhood Vaccinated for Brucellosis. (Optional)
- 6.) All Two Year Old Heifers, Three and Four Year Old Cows must be pregnancy tested and certified to be at least 90 days bred and safe with calf by a veterinarian.
- 7.) All bison ages must be verified by a veterinarian and indicated on the health certificate. Animal ages will be determined by looking at the adult incisors, which have fully erupted if so deemed necessary by the judges.
- 8.) All 2 Year & Yearling Bulls must be semen checked and certified fertile. Scrotal circumference should be documented on Health Certificate or Semen papers.
- 9.) All animals must be officially treated for parasites by injection with Ivomec or equivalent treatment within 30 days prior to sale date. **Must** be noted on Health Certificate.
- 10.) Two (2) copies of the Health Certificate must accompany each animal. (See packet for instruction concerning your health certificate.)
- 11.) Animals **will not** be unloaded if the Health Certificate doesn't meet **ALL** of the above requirements.
- 12.) All females other than calves must be certified open or pregnant.

Ear Tags

The Eastern Bison Association Show and Sale ear tags will be supplied by the EBA and assigned to each animal consigned to the Show and Sale. The consignor will be responsible for applying these tags in the assigned animals LEFT ear (same side of head as your left ear). All ranch identification ear tags must be removed. Ear tags acceptable include the NABR registration tag, the metal brucellosis vaccination and/or ID #, RFID tag and the issued Show and Sale tag in left ear.

Horns

Animals will be accepted into the Show and Sale with either, 1) two good horns, 2) dehorned or 3) broken horns, which have healed. Freshly broken horned animals will not be accepted or remaining horn will be removed at Show & Sale location. We recommend that calves are **NOT** dehorned.

Entry Fee

The entry fees are: \$60.00 for each animal, \$90.00 for pair of aces, \$90 for pen of 2 and \$125.00 for carcass class. Fees are required upon entry of each animal. The entry fee is NON-REFUNDABLE.

Entry Deadlines

February 18, 2020

Entry Limits for Consignor

- I. Two entries per class, per consignor. One for 2 Year Bulls, Pair of Aces, Pen of 2 and Carcass Class.

Note: Limits per class may increase depending on overall entries.

Note: These animals must have been born in the spring of the applicable year.

2 Year Old Bulls – A consignor may bring only one 2 Year-Old Bull. **The 2 Yr.-Old Bull may have 2 - 4 adult teeth and the bull is not required to be teeth certified. A Two-Yr. Old Bull with any evidence of a 5th tooth during check in will be fined \$50 and the animal will be disqualified. The owner will have the option of leaving the disqualified animal in the yards at the \$150 yardage fee or loading the animal back on the trailer.**

2-Yr.-Old Bred Females – See Bison Teeth Certification Form!

Grass Fed Bull Calves and Grass Fed Heifer Calves - A Grass Fed Producer Affidavit must accompany this entry form. The Grass Fed Producer Affidavit is available on the EBA website.

The show and Sale Committee's goal, by setting the above limits, is to improve overall quality and variety in the Show and Sale. Limits per consignor will be strictly enforced. Limits per class may flex depending on overall entries.

Commission

A commission of 10% will be taken off the gross sale price of each animal sold at the auction.

Liability

The consignor assumes all responsibilities in regard to the above mentioned terms and conditions of this show and sale including but not limited to: proper documentation of a positive pregnancy test (where applicable) and documentation of age. The EBA acts only as an agent and will assume No responsibility in the event of injury or death to any animal or for any discrepancy between the buyer and the consignor.

In accordance with the Harrisburg Farm Show Complex/EBA regulations, a sifting committee will be appointed to look over the animals entered and any animals deemed to be without merit as would entitle them to exhibit, the EBA Show & Sale committee may require them to be removed from the Harrisburg Farm Show Complex grounds. Judges reserve the right to disqualify any animal from the show and sale if in their opinion there is reason. The reasons include, but are not limited to the following: animal appears to be diseased, injured, in poor condition or of wrong age.

The EBA assumes NO RESPONSIBILITY for any animal before, during or after the Show and Sale.

I affirm the non-use of growth stimulants or steroids. I agree to testing of consigned animals during the Show and Sale. I affirm that our animal(s) have not been treated for any health or medical conditions in the previous 30 days other than the requirements for this Show and Sale.

I have read the above mentioned terms and conditions of the 2020 Bison Show and Sale and agree to abide by them.
